- SUBMIT ONLY ONE PRE-APPLICATION PER FAMILY; IF A FAMILY SUBMITS MORE THAN ONE PRE-APPLICATION, THE APPLICANT WILL BE DISQUALIFIED AND THE PRE-APPLICATION WILL NOT BE CONSIDERED FOR THE LOW RENTAL ASSISTANCE PROGRAM.
- FAILURE TO PROVIDE ANSWERS TO ALL QUESTIONS WILL RESULT IN A DISQUALIFICATION WITHOUT AN APPEAL.

THE WAITING LIST WILL BE STRUCTURED IN ACCORDANCE WITH HUD REGULATIONS AND THE ADMINISTRATIVE POLICY OF THE WPHA. A LETTER CONFIRMING RECEIPT OF THE PRE-APPLICATION WILL BE MAILED TO THE ADDRESS LISTED ON THE PRE-APPLICATION AFTER THE CLOSE OF THE WAITING LIST.

ELIGIBLE APPLICANTS MUST MEET ALL HUD'S REQUIREMENTS RELATING TO INCOME, CITIZENSHIP OR ELIGIBLE IMMIGRANT STATUS. IN ADDITION, ALL PERSONS ARE WELCOME TO APPLY; HOWEVER, PREFERENCE WILL BE GIVEN TO WHITE PLAINS AND WESTCHESTER COUNTY RESIDENTS AND PERSONS EMPLOYED WITHIN THE CITY OF WHITE PLAINS OR WESTCHESTER COUNTY.
